The head office of the organization is located in Kabul, Afghanistan, and delivers humanitarian services in the sectors of Livelihood, Good Governance, WASH, and Emergency through its four regional offices in Mazar, Herat, Jalalabad, and the central zone in a decentralized manner.

### Job Description:

#### Roles and Responsibilities:

- Build strong relationships with community members including community leaders in the target provinces.
- Conduct community assessments to understand their needs, challenges, and priorities related to the project components.
- Organize and facilitate community meetings, focus group discussions, and awareness sessions to gather community input and promote participation.
- Act as a liaison between the community and the project technical team, conveying relevant information, concerns, and feedback.
- Conduct community-based awareness sessions on community project overall objectives, goals, and output.
- Conduct field monitoring visits to monitor cash program activities/interventions against Quality Checklists and produce & share weekly reports to the concerned program team as well as the management team based on quality and accountability findings and incorporate inputs from the program team in an agreed action plan
- Highlight promptly if the targeting and distribution practices of the program are not in line with agreed processes and provide support as necessary
- Organize and coordinate training sessions for community members according to the project planning and skill development.
- Collect data and information from beneficiaries, documenting their progress, challenges, and success stories related to the project improvements.
- Prepare and submit timely reports to the project manager, including activity reports, training/event reports, and success stories.
- Collaborate with the Monitoring and Evaluation (M&E) team to provide accurate and up-to-date information for project monitoring and reporting purposes.
- Establish and maintain effective coordination with local authorities, line departments, community leaders, and other relevant stakeholders.
- Participate in relevant meetings, workshops, and events to represent the organization and share project updates and achievements.
- Any other tasks assigned by the line supervisor.
