The Site Engineer ensures the overall success of the project by making sure the project team completes the defined activities according to the plan and that the activities are completed on time and of acceptable quality.

- Implement CFW and Infrastructure activities in the project.
- Preparing cost estimates and ensuring appropriate materials and tools are available.
- Providing technical advice and suggestions for improvement in the projects.
- Authorizing technical drawings and engineering plans.
- And Prepare schedules and communicate any adjustments with staff members.
- Gathering data, compiling reports, and delivering presentations to relevant stakeholders.
- Delegating tasks and scheduling meetings and training sessions where required.
- Completing quality assurance and providing feedback to the team.
- Visiting project site regularly and provides, daily, weekly, and monthly reports.
- Monitoring construction/rehabilitation, canal cleaning activities as per standards and agreed specifications.
- Recommend and implement a capacity building/development plan for project staff based on capacity needs assessments.
